The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: I observed the defendant driving a white Acura with FL tag GKZM89 on the roadway. He was traveling at a high rate of speed on W. Cleveland St approaching a red light. He ran the red light and made a wide left turn across 2 lanes and almost struck the raised curb. He continued South on S. Armenia Ave at a high rate of speed and I got behind him and activated my emergency lights. He continued forward and did not react to my lights. I activated my siren and he still did not react until we passed S. Tapania St. He then pulled quickly to the right at an angle and stopped with his right front tire against the raised curb. I made contact with the defendant who was in the driver's seat. Upon contact I could smell a strong odor of alcoholic beverages from his breath. His eyes were glassy and bloodshot. He performed field sobriety exercises and showed impairment. Post arrest I advised him of implied consent. He understood and refused to provide a breath sample. A check on NCIC/FCIC showed he had a prior suspension for a refusal to submit to a breath test ON 07-23-17 in Pasco County. Defendant ID'd by FL DL.
