(Specifically include facts constituting cause for arrest.)</p> <p>On Thursday, June 17, 2021, at approximately 2222 hours, I was conducting traffic enforcement at 6500 block of S Military Trail, Lake Worth, FL 33462.</p> <p>While conducting traffic enforcement, I was facing northbound and observed two vehicles travelling southbound on S Military Trail coming from Lantana Rd. I observed a White 2017 Ford Focus FL tag # BIG00F accelerating alongside another vehicle (see case # 21-077065 reference the other vehicle) and reaching a speed of 90 mph in a 45 mph zone. I visually estimated the speed at 90 mph and confirmed the speed with my PBSO issued mounted radar unit, STALKER DUAL SL SERIAL # DC108113 / FRONT ANTENNA # KC064072 / REAR ANTENNA KC064467. I confirmed the speed with the audio Doppler from the unit and maintained visual as I approached the vehicle. As I spoke to the sole occupant and driver, Kobe Kwong, I asked why Kobe was going that fast alongside another vehicle and Kobe stated, "I just wanted to show off."</p> <p>Based on the observation in my presence, and totality of the circumstances, where Kwong drove a motor vehicle in a speed competition with another vehicle and continued to exhibit speed and acceleration on a county road. I found probable cause to arrest Kwong for Street Racing pursuant to Florida state statutes 316.191 (2)(A).</p>
