I GOT BEHIND THE VEHICLE AND WATCHED AS IT ALMOST STRUCK THE MEDIAN AS IT APPROACHED THE PARK BLVD BRIDGE. THE VEHICLE WAS IN THE TURN LANE TO GET ON THE BRIDGE WHEN IT HAD TO MAKE AN ABRUPT TURN BECAUSE IT ALMOST DROVE STRAIGHT IN TO THE MEDIAN INSTEAD OF TURNING WITH THE ROADWAY. 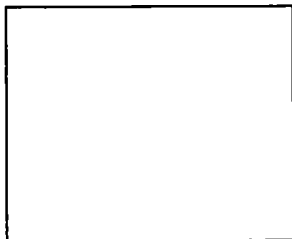
