The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was driving a 2017 white Ford Mustang bearing a Florida license plate of RLP618. She was traveling north on Howard Ave and made a wide left turn onto Kennedy Blvd. The vehicle was then weaving back and forth, and made a wide right turn onto N MacDill Ave, nearly striking a vehicle that was in the southbound lane. The vehicle sped up to, and was paced at, 46 MPH in a 35 MPH zone. A traffic stop was made and upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, fumbling fingers, a strong odor of an alcoholic beverage, and an admission to consuming alcohol. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later submitted to a breath test which had a BrAC result of .162 and .163.
