The defendant was operating a 2007 Toyota 4dr bearing Florida tag LJSV43 . The defendant was stopped for speeding 65 in
a posted 50 mph zone by Officers Zawacki and Torres. During observations, the defendant displayed multiple clues of
impairment to include, watery/glassy eyes, slurred speech, and the distinct odor of alcohol emanating from her breath. She
also admitted to consuming "wine" at Busch Gardens.

During SFSEs, the defendant displayed additional clues of impairment, and was arrested for DUI. The defendants two daughters ages 11 and 12 were passengers in the vehicle.

While at Central Breath Test, the defendant provided a breath sample, which yielded a BrAC result of .128/.131
