## PERSONAL CONTACT

### DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

This Officer was conducting a traffic enforcement selective (20165088), in the area of 9800 Alt A1A, PBG, FL. This Officer observed a vehicle traveling North bound in the inside through lane at an increased rate of speed. This Officer's initial visual estimation of the vehicle was approximately 60 MPH, in a posted 45 MPH zone. Using RADAR Stalker DSR2X (Serial #DB001317) rear antenna (KR027120) this Officer received a steady tone and reading of 58 MPH. This Officer entered traffic flow behind the vehicle, a black sedan Kia (ECBS13/FL) and observed the vehicle drive off the roadway at the intersection of Alt A1A and Promenade Plaza. This Officer also received a steady reading from forward facing antenna (KC086606) of 58 MPH, as the vehicle would rapidly accelerate and decelerate. This Officer further observed the vehicle drifting between lanes multiple times before turn right to go West bound on Burns Rd. This Officer initiated a traffic stop on the vehicle under the Interstate 95 overpass of Burns Rd in PBG, FL. This Officer made contact with the driver and sole occupant of the vehicle, identified via Florida Driver License photo, Kristeena Lyon, while she was still in actual physical control of the vehicle.

### OBSERVATION OF DRIVER:

Lyon had bloodshot watery eyes, a flushed red face, slurred speech and the obvious odor of an unknown alcoholic beverage emanating from her breath at conversational distance. Lyon displayed rapid mood swings where she would go from upset to verbally non compliant and yelling at this Officer.

### DRIVER'S STATEMENTS:

Lyon said she was coming from downtown and at first said she had consumed one alcoholic beverage then said she had consumed two beverages. Lyon claimed she had just broken up with her boyfriend and was out celebrating her birthday.

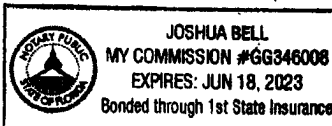

Lyon had Vertical Gaze Nystagmus in both eyes and was swaying back and forth during the exercise.

**WALK & TURN:**

During the instructions Lyon did not remain in the starting position. Lyon stepped off the line and raised her arms multiple times. Lyon also had difficulty getting into the starting position for this Officer to provide instructions in the proper manner. Lyon also started prior to being told to do so, multiple times. During the exercise, Lyon kept her arms raised more than six inches from her sides. Lyon missed heel-to-toe on multiple steps, counted 15 steps aloud however took 16 steps. Lyon did not conduct a turnaround at all, rather said her name and asked to go home. On the return set, Lyon missed heel-to-toe on each step and again kept her arms raised well over six inches from her sides. Lyon counted 13 steps aloud, however, took 14 steps. Lyon also stepped off the line on multiple steps during the return set.

**ONE LEG STAND:**

During the exercise, Lyon raised her left foot. Lyon kept her arms raised for the majority of the exercise and was swaying throughout the duration. Lyon also placed her foot down multiple times prior to being told to do so. It should be noted, Lyon counted out of order and had to be told to look down at her raised foot.



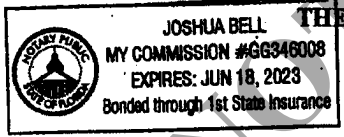
