The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
During the course of a traffic stop on a vehicle bearing a tag that was not assigned (reference TPD Event #20-407723), a syringe was observed atop the front passenger seat to the immediate right hand side of the Defendant's right leg on her seat. She was detained in handcuffs at this time.

During an inventory search of said vehicle, two pocketbook style purses were located on the front passenger side of the center console within the listed vehicle. These purses were noted to be positioned atop the Defendant's left leg/ lap area during initial contact with the Co-Defendant during the traffic stop. A clear glass pipe with residue was located within one of the purses, consistent with a pipe that is used to smoke methamphetamine. After dumping the contents of the purse on the ground adjacent to the passenger side of the listed vehicle, a white colored rock-like substance with power was observed to have fallen onto the ground from the purse. Presumptive field tests were performed on the pipe and mentioned white substance using agency issued test kits, yielding positive results for meth/ ecstasy.

The Defendant was provided with the Miranda warning via agency issue card, and advised that she understood the warning. While on scene, the Defendant advised that she distributes syringes to people.

Affiant positively identified the Defendant via RMS photograph.
