Gideon stated she was pushed against her will and did not want the interaction to be physical and only wanted to prevent others from being hurt.

O'Brien started by saying she should of never came to the beach in the first place. O'Brien said she saw on Instagram that Lopez was hanging out with Vilela who she believes is hooking up with her ex-boyfriend Lopez. In the Instagram story it showed them at the beach. O'Brien stated she went to the beach to confront him about it. O'Brien then said that she was arguing with Lopez and had pushed him during the argument. When some of Lopez's friends tried to intervene, O'Brien described herself as "Blacking Out" and she pushed Vilela away. Vilela was the one who posted on Instagram of them at the beach. 


