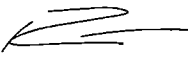

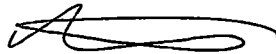
ADVISORY AND SOLVENCY HEARING

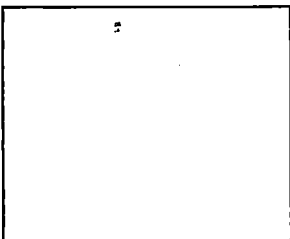
