DRIVING PATTERN: (Actual Physical Control; Physical Evidence or Statements Putting Defendant Behind Wheel of Vehicle)

Officer Sam Warren, was patrolling the intersection of N Military Trail and PGA Boulevard, Palm Beach Gardens, Palm Beach County, FL, when he heard a vehicle running over the light reflectors on the roadway of PGA Blvd. There was only a red SUV, traveling eastbound on PGA Blvd and it had no lights on. Officer Warren conducted a traffic stop on the vehicle, a 2017 Mitsubishi Outlander bearing FL tag: LTU211, for the violation at PGA Boulevard and Interstate 95 with the final location of the stop at Lake Victoria Gardens Avenue. CLOTHING: Green tank top, blue ripped jeans, brown sandals

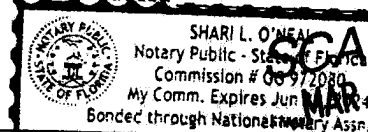

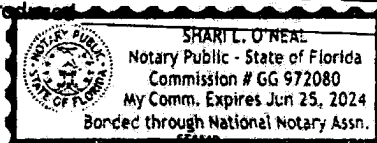
