at approximately 2:24 AM, at 3398 TAMPA RD, in Pinellas County did:

UNLAWFULLY OBSTRUCT OR OPPOSE SGT J. ARNTZ, A DULY AND LEGALLY CONSTITUTED LAW ENFORCEMENT OFFICER OF THE PINELLAS COUNTY SHERIFFS OFFICE, WHILE IN THE LAWFUL EXECUTION OF A LEGAL DUTY, WHICH CONSISTED OF REFUSING TO FOLLOW LAWFUL COMMANDS GIVEN WITHOUT OFFERING OR DOING VIOLENCE TO THE PERSON OF THE OFFICER.

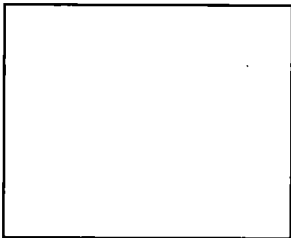
