The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 Knowing and unlawfully commit the offense of DUI, to wit:

The defendant was operating a 2015 white in color Ford Mustang bearing Florida Tag# NPXU70. The defendant was initially observed accelerating rapidly/"fishtailing" from a parking lot at the 400 Block of Howard Av S. The defendant was also observed driving without taillights (the headlights were not switched to on but running lights were activated) and she stopped past a stop bar at a stop sign. A traffic stop was conducted on the defendant's vehicle and upon making contact with the driver/defendant (sole occupant in the vehicle), the defendant was observed to have bloodshot/watery eyes and the strong odor of burnt marijuana was emanating from inside the vehicle. The defendant handed Affiant un-smoked marijuana as well as smoked marijuana and an open alcoholic beverage container was observed in the backseat of the vehicle. The odor of alcoholic beverages was later smelled emanating from the defendant's breath during the Field Sobriety Exercises. The defendant admitted to consuming an alcoholic beverage and smoking marijuana "5 hours earlier". The defendant participated in the Field Sobriety Exercises and demonstrated clues of impairment. Post arrest, the defendant provided breath samples of .054/.055 BrAC. The defendant also provided a urine sample for chemical/controlled substance impairment (results are pending). The defendant was positively identified via Connecticut Driver's License. Affiant identified the defendant as the driver of the vehicle.
