On 02/22/2020 at approximately 1230 hours, I responded to 1028 Hallwood Loop., Brandon FL, 33511 in reference to a domestic in progress call for service. The defendant and victim engaged in a verbal argument which became physical when the defendant unlawfully struck the victim with a stick on the upper portion of the victim's left arm, resulting in a dark colored contusion.
