The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 5/2/2020, at approximately 0140 hours, at Palm River Rd. / 58th St. S., Tampa, FL 33619, I conducted a traffic stop on a beige Toyota Prius (bearing DMQR59 / VIN: JTDKB20U163146125), for speeding and failure to maintain a single lane. Upon making contact, the defendant was observed to have slurred speech, glassy, bloodshot eyes, and he fumbled to locate his vehicle registration and paperwork. The defendant also admitted to having consumed several alcoholic drinks prior to driving. The defendant was given the opportunity to perform field sobriety exercises, which he did poorly indicating impairment. Subsequent to arrest, the defendant provided breath samples of .175/.170 after a twenty minute observation period. The defendant identified himself verbally, which was confirmed via Florida driver's license S143519954090.
