The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 07/16/2021 at approximately 0423 hours, on Highway I-75 near near the cross road of Highway 301 South, Riverview, Florida 33578 the defendant was observed by Deputy D. Pincay ABN: 253763 operating a blue 2020 Hyundai Elantra bearing Texas tag MVN1265 with an assigned VIN of 5NPD84LF0LH568242 driving well above the listed speed limit and failing to maintain a single lane. Upon Deputy Pincay's contact with the driver, he observed multiple indicators of impairment. Upon the affiant's contact with the defendant, she had a red in color face, she had slurred speech, she had watery/glassy eyes and I smelled the strong odor of an alcoholic beverage emitting from her breath. The defendant elected to participate in field sobriety exercises, and while doing so she demonstrated further indicators of impairment. After taking the totality of the circumstances and the defendant's indicators of impairment into consideration, she was placed under arrest for DUI. The defendant was arrested for DUI and she provided two lawful breath samples roadside of .123 and .113. The defendant identified himself verbally. I further identified the defendant via her DAVID photograph.
