He was traveling south on Dale Mabry Hwy and paced traveling 53 MPH in a posted 40 MPH zone. He then made a right turn to go west on El Prado Blvd and was paced traveling 43 MPH in a posted 30 MPH zone. A traffic stop was made and upon making contact with the defendant he displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, and an odor of an alcoholic beverage on his breath. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later submitted to a breath test which had a BrAC result of .135 and .146.
