The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On October 28, 2020 at approximately 2219 hours, the affiant heard multiple loud banging sounds coming from the affiant's marked city of Tampa patrol vehicle (#224). The affiant observed the defendant walking away from the patrol vehicle. The defendant then paused and arched his back, while looking down, and still standing up. Contact was made with the defendant (to check on his well-being) as he was getting into his personal vehicle. The defendant spontaneously stated that he had a fight with his girlfriend and struck the patrol vehicle because he was upset and it was the closest thing to his own vehicle. Post-Miranda, the defendant admitted to having several drinks and punching the patrol car because he was upset over his break-up. The defendant could not maintain his stance, had the strong odor of alcoholic beverages emanating from his breath, slurred speech, and bloodshot/dilated eyes. The affiant was unable to determine and view any damage to the patrol vehicle. The defendant was identified via his DSHMV photograph.
