 On 9-12-2020 at 1007 hours, at the Walmart at 2701 Fletcher Av E, the defendant unlawfully placed \$685.46 worth of items in his cart, entered the self-checkout lane, and then walked past all points of sale with the intent to permanently deprive Walmart of the full retail value before being apprehended by deputies.
