

On 03/10/2021 at approximately 1055 hours the defendant, Kyle Hauser (DEF) was observed forcibly and intentionally grabbing the 2-year-old victim while in the custody and care of the grandmother, Rosaluz Castillo (WI). The defendant confined the 2-year-old victim within his arms, refusing to allow Castillo to regain control and attempted to back away from where they were standing. After tugging for possession of the 2-year-old victim with the defendant, Castillo was able to regain custody with the assistance of nearby witness, Lacey A. Siegal and Cecilia Tang. The brief confinement of the victim was done without her or his will and without the consent of her or his parent or legal guardian.

The two witnesses, Siegal and Tang were able to give their accounts of what they observed, stating they saw the defendant lingering around the playground area in an unusual manner. He then without provocation "scooped" the victim up into his grasp and refused to let go even after physical attempts by Castillo to defeat his hold on the 2-year-old victim. Both Siegal and Tang's verbal statements coincided with what was said by Castillo (Spanish speaker) as well.

The defendant's father, Glenn Hauver was on scene and mentioned to officers that his son had been having mental issues lately and has been medically diagnosed with schizophrenia within the year of 2021. Although his son was recently given this medical diagnoses, Glenn Hauver explained that his son has never acted out in this manner and has always known the difference between a right from wrong act; exempling that he has held high titles within business companies and even cared for his own young child without ever having complications.

The defendant was read his Miranda Warnings via issued Boca Raton PD Constitutional Rights card and refused to speak to officers. My investigation revealed that the
