The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 2/17/2021, at approximately 1923, the defendant was operating a blue Cadillac bearing FL tag EHHI32 (VIN:1G6EL12Y4RU604438). The defendant struck a white Hummer bearing FL tag PG991T (VIN:5GTDN136368291380). The witness was driving the white Hummer and positively identified the defendant as the person that was driving the blue Cadillac at the time of the traffic crash (Reference HCSO event 21-108371, DHSMV crash #89444652). Affiant responded to the scene, detected the distinct odor of an alcoholic beverage emanating from the defendant's breath, he had bloodshot and glassy eyes, and he was lethargic in his movements. Affiant requested the defendant perform Standard Field Sobriety Exercises (SFSEs) which the defendant refused to perform, and was subsequently arrested for DUI. Deputy S. Thorne ABN 234165, who is a certified Breath Technician, arrived on scene in his unmarked HCSO vehicle which is equipped with an intoxilyzer. The defendant refused to provide a lawful sample of his breath to determine his breath alcohol content (BrAC). Affiant read Implied Consent to the defendant, he understood and replied "No." The defendant was identified via FL DL. The defendant was given DUI citation 3579XGA which reflects the DUI charge.
