NARRATIVE:

I am part of a National Task Force known as the South Florida Internet Crimes Against Children (ICAC). This task force investigates internet crimes against children, child exploitation, and related cases.

On October 1, 2019, I was assigned to further investigate Cyber Tip #53542614 received from the National Center of Missing and Exploited Children (NCMEC). Cyber Tips are investigative leads generated by the National Center of Missing and Exploited Children (NCMEC) in the prevention of abducted, endangered, and sexually exploited children. NCMEC works with law enforcement, Internet Service Providers, electronic payment service providers, and others to reduce the distribution of child sexual exploitation images and videos over the Internet.

On August 12, 2019, Dropbox reported an unknown user using the email address of petemitchell45@protonmail.com and screen name of Pete Mitchell had uploaded 4 images which depicted the sexual performance of minors. Dropbox is an online "offsite" storage medium for data that can be accessed and viewed at any time from any computer or electronic storage device capable of accessing the internet.

On October 8, 2019, a subpoena was served to Comcast to obtain basic subscriber information for the IP (internet protocol) address that was used to upload the files to Dropbox (2601:58c:c000:480:c1c0:4079:f7b9:78d). Comcast returned subpoena results which indicated that the subscriber for suspect IP address was reported to be Kyle Ewart located at 22042 Boca Place Drive Apartment 8112 in unincorporated Boca Raton, FL (Palm Beach County). The Comcast account was still active and the phone number listed on the account was 816-809-7058.

Detective Grimaldi reviewed the images provided my Dropbox and confirmed (1) image to meet the elements of child pornography as defined by Florida State Statue. The image depicted a prepubescent naked female estimated to be approximately 9-11 years of age in various sexual poses.

NARRATIVE CONTINUATION

On March 6, 2020, Detective Grimaldi made contact with Kyle Ewart for the purposes of conducting a recorded interview. Post Miranda Ewart confessed to being interested in child pornography for approximately 1 year. Ewart viewed child pornography as much as 2 weeks ago. Ewart knew that what he was doing was illegal and admitted that he had a problem he couldn't control and needed help for. He admitted to sexually pleasuring himself while viewing the photos. Ewart provided written and recorded consent to search his phone. The Dropbox application as well as Photo Vault and Mega were located. All 3 accounts are used for cloud storage. Detective Grimaldi viewed more than 10 photos depicting young prepubescent naked females in different sexual positions. The minor children ranged in age from approximately 7 or 8 years of age up to puberty.

Based on my investigation and evidence gathered, I find probable cause that Kyle Ewart did knowingly possess and intentionally view sexual conduct by a child in violation of F.S.S. 827.071(5). Ewart was placed under arrest and transported to the Palm Beach County Main Jail.
