On October 14, 2017, Special Agents of the West Palm Beach and Fort Pierce District Offices with the Florida Division of Alcoholic Beverages and Tobacco (FDABT), Bureau of Enforcement were working the Florida Georgia Line Concert, located at 601-7 Sansbury Way, West Palm Beach, FL. Special Agents were working the parking lot in reference to underage persons in possession of alcoholic beverages and other criminal violations.

At approximately 5:43 p.m., while wearing a distinguishable police uniform, Special Agent Richard Allen witnessed a youthful looking male that was in possession of a bottle of Corona Extra alcoholic beverage. Allen approached the male and asked how old he was? The male stated he was 19 yrs old. The male produced her identification that showed she was 19 yrs old.

Allen identified the male as Kyler Siegert, DOB 01/23/1998, 19 years old (FL DL #S263-503-98-023-0). Allen charged Siegert with a violation of Florida State Statute 562.111(1), possession of an alcoholic beverage by a person under the age of 21. Siegert signed the Notice to Appear and agreed to show up in court on November 7, 2017. Allen took a photo of Siegert and it is retained at the West Palm Beach District Office.

There was no evidence to submit in this case.
