The defendant was operating a white 2015 Kia Sportage, 4 door, Missouri tag CV9B7Z. The defendant drove the vehicle in a manner in which the vehicle was weaving within the travel lane, and the left and right side tires crossed onto and over painted lane markers multiple times. A traffic stop was conducted in order to check on the driver's condition to determine if she were sick, tired, distracted, or impaired. The defendant had a distinct odor of an alcoholic beverage on her breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's speech was slurred, and her face was flushed. The defendant stated she drank one vodka and Red Bull drink tonight. The defendant was uneasy as she exited the vehicle, and she swayed noticeably while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and based on a totality of the circumstances was arrested for DUI. The defendant provided breath samples of .182% BrAC and .184% BrAC. The defendant was positively identified by her MO DL.
