restrain and put the handcuffs on him. The handcuffs were double locked and checked for fit and Theophile was placed in the back of my marked patrol vehicle. Police Officer Trimble placed handcuffs on Boniello which were double locked and check for fit, and she was placed on the back of Police Officer Trimble's marked patrol unit.

After Boniello and Theophile were placed in the vehicles Police Officer Bussek and I began to search the vehicle. A search of the vehicle revealed that Boniello was in possession of two metal grinders, one white plastic grinder, black electronic pipe, THC wax, two blunt cutters, two glass containers containing THC oil, two bags containing delta 8 gummies, one big jar of delta 8 gummies, and 198.2 grams of cannabis in multiple packages.




Just as we finished searching the vehicle Police Sergeant Ciezak, Police Officer Bussek, and I heard Theophile banging inside of my marked patrol vehicle it seemed as if he was trying to break the door. I ran over to my vehicle and proceeded to open the door. As I opened the door Theophile was screaming and he kicked me in the groin. I took Theophile out of my marked patrol vehicle and he continued to put up a fight and yell that his cuffs were too tight. Police Sergeant Ciezak, Police Officer Bussek, and I were making efforts to try and readjust the handcuffs, but Theophile kept putting up a fight and would not let us. Police Sergeant Ciezak, Police Officer Bussek, and I were able to escort Theophile to the ground and restrain him to readjust the handcuffs. Handcuffs were checked for fit once again and double and Theophile was placed back into my marked patrol vehicle where he continued to scream and kick the door. Eventually he stopped kicking the door.

Boniello and Theophile were transported to the North Palm Beach Police Department with all their belongings and placed into separate holding cells.

Theophile continued to resist as Police Officer Wright was trying to place him in the cell. He stated that his wrist and his pinky fingers were hurting, however he kept banging on the windows, walls, and doors of the holding cell. Theophile also took off his shirt and began to do pushups within the holding cell and maintained his aggressive attitude towards law enforcement.

Based on my investigation and the totality of the circumstances Kylissa Boniello was knowingly in actual or constructive possession of 20 grams or more of a material, compound, mixture or preparation which contained cannabis, commonly known as marijuana, a controlled substance, contrary to Florida Statute 893.13(6)(a)

Also Kylissa Boniello did use or possess with intent to use three grinders, two blunt cutters, electronic pipe, and rolling papers, drug paraphernalia, for injecting, ingesting, inhaling, or otherwise introducing into the human body a controlled substance, contrary to Florida Statute 893.147(1)(b).
