committed the below acts in my presence.  was observed by **MARTEL, LESLIE** who told **OFC. BARKER** that he/she saw the arrested person commit the below acts.

confessed to admitting to the below facts.  was found to have committed the below acts, resulting from my (described) investigation.

On the 18 day of March, 2020 at 22:09 (Specifically include facts constituting cause for arrest.)


On March 18, 2020 at approximately 10:09 p.m. I was dispatched to 4335 Union Square Boulevard Apartment 170, Palm Beach Gardens, Palm Beach County, Florida; in reference to a disturbance.

On arrival, I observed a Hispanic female wearing a black shirt and black pants running from the direction of where the disturbance was being reported. Shortly after, officers advised a Hispanic female wearing dark clothing is involved and left the scene. I ran after the female and was able to catch her after a short foot pursuit. The female, later identified as Lajuan Garcia, appeared intoxicated and did not wish to talk to officers. She only implied there was an argument and that she would handle it but would not specify any further. While being detained, Garcia stated to Officer Mangel that her family are all gang members and that she would kill him multiple times.

Officer Barker made contact with the victim, later identified Leslie Martel, who provided a sworn verbal statement advising the following: her, Garcia, and their other friend Nicholas Jeffress were sitting on the couch having a "heated conversation about life". During the conversation, Martel stated Garcia got angry and reached over Jeffress then punched Martel in the face area. Martel was able to put her arm up just in time to prevent Garcia from making contact with her face but was still struck. Martel then told Garcia to leave and she did. Martel declined medical attention and stated she wanted to prosecute for the crime.


Officer Zuccarelli made contact with Jeffress who advised the following, he was at the residence hanging out with his friends, Martel and Garcia. While there, Jeffress stated an argument ensued between Garcia and Martel. Jeffress said he observed Garcia reach over him and strike Martel in the face, but Martel was able to block her face with her hand. Jeffress then heard Martel kick Garcia out and he attempted to run after her once she left.




<p>Based on the above facts and circumstances, Lajuan Garcia was placed under arrest and is being charged with battery, in violation of F.S.S. 784.03(1)(A)(1). Garcia was transported to the Palm Beach Gardens Police Department booking facility where she was searched for weapons by Officer Slaughter. While being searched outside of the car, Garcia said "fuck you" to me and kicked me on the left inner thigh with her leg. After being restrained, Garcia stated she did it on purpose. It should be noted at the time the battery occurred I was in Palm Beach Gardens Police Department uniform and clearly identified as a police officer. Garcia was additionally arrested for battery on a law enforcement officer, in violation of F.S.S. 784.07(2)(B) and threat with death or serious bodily harm to a law enforcement officer, in violation of F.S.S. 836.12(2). This incident was recorded on my body worn camera.</p>
