She provided me a FL ID and was identified as Lanai T. Barreto. Barreto was not committing a crime at the time and required no further police assistance. She stayed in the area as I walked away.</p> <p>At 1736 hours on the same date, 12/24/21, Mizner Park Security contacted BRPD about the same female causing a disturbance outside of Max's Grill, 404 Plaza Real, Boca Raton. I met with the Security Officer who advised that Barreto was screaming and cursing, and they wished to have her trespass from Mizner Park. I approached Barreto with the Security Officer who issued the trespass warning to Barreto in my presence. Barreto began walking toward N. Federal Hwy. but stopped before she exited the property. I advised her that she had been issued a trespass warning and if she did not leave the property she would be taken to jail for trespass after warning. I repeated that statement at minute 7:06 on my BWC. I gave Barreto "one more chance". I advised her "if you don't leave right now you are going to jail for trespass after warning". I asked her "are you leaving, are you leaving"? Barreto refused to leave.</p> <p>Based on my investigation/observation I found that Lanai Barreto was in violation of F.S.S. 810.09(2b) - Trespass on property after warning, when she remained inside of Mizner Park after being issued a trespass warning, in my presence, by a Security Officer of Mizner Park. Barreto was placed in handcuffs behind her back (double locked and checked for tightness using the finger gap method). Officer Ricciardi arrived on scene and searched Barreto's person before she was placed in the rear passenger seat of Officer Grubb's vehicle. Officer Grubb's transported Barreto to the BRPD and sat with</p>
