On Friday, April 8, 2022, I was dispatched to the Palm Beach Gardens Police Department located at 10500 N Military Trl in the City of Palm Beach Gardens, Palm Beach County, FL in reference to a violation of a court ordered injunction. My department issued body worn camera was used on this call. Upon arrival I made contact with Katherine Buettin. She was placed under oath and provided the following sworn statement. She advised she was made aware by multiple friends that her ex-boyfriend, Lance Burge, posted a status on his Facebook account directing a message to her. The temporary injunction for protection prohibits Burge from contacting Buettin in anyway. Burge's Facebook post stated, "4/14/2022 9:30AM Katherine Elizabeth Buettin, you have a court date for repeat domestic violence, do not contact order, malicious interference into a person's livelihood, stalking and cyber stalking...whoever is feeding you this information should attend" (posted on 4/6/22 at 9:11pm from Facebook page Lance Addison Burge). Burge was served the injunction paperwork by PBSO Deputy Pavlov on 4/5/22 at 4:09pm Probable cause exists to charge Lance Burge with violating an injunction as he did willfully, after having been served with an Injunction for Protection Against Domestic Violence issued pursuant to section 741.30 or a foreign protection order accorded full faith and credit pursuant to section 741.315, did contact Katherine Buettin by telephone, or otherwise communicate with Katherine Buettin directly or indirectly, contrary to F.S.S. 741.31(4)(a)5.
