The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 09-09-2020 at approximately 0344 hours, I responded to the Valet area located at Seminole Hard Rock Casino located at 5223 Orient Rd, Tampa FL in reference to a Disturbance.

Upon arrival contact was made with the suspect a white female who was later identified via her FL DL as, Latashia Morris, DOB 08-02-1987. Ms. Morris advice she was in a violent relationship and she finally decided to leave today and came to the casino because she felt safe here. While talking to Ms. Morris it was discovered she had an active warrant out of Polk County which was confirmed, Ms. Morris was arrested for the warrant by Officer Heintz (see case number 2020-03313), at which time she was asked if she had anything illegal in her possession prior to be taken to jail to which she stated yes. Ms. Morris advised she had the drugs in her bra and she will be willing to retrieved it, she reached in her bra and retrieve two (2) clear plastic baggies with a crystal like substance to which she stated it was Methamphetamine (who was later field tested and tested positive to Methamphetamine). Ms. Morris also retrieve an unknown rose color pill that she advised it was Ecstasy the unknown pill tested positive to MDMA.

At this time Ms. Morris was charged with possession of a control substance.

The weight of the two (2) methamphetamine baggies was 1.2 grams combine.
