The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 03/30/2021, at approximately 2112 hours, I responded to 232 Van Gogh Cr, Brandon, FL 33511, in reference to a domestic violence call for service. Upon arrival, I met with the defendant and victim and ascertained the following had occurred: The defendant and victim were engaged in a verbal altercation that turned physical when the defendant jumped on the victim's back and began scratching his facial area, neck and head. I observed minor scratches on the victim's head. Based on statements obtained from both subjects, I determined the defendant to be the primary aggressor in the altercation. The defendant and victim are boyfriend and girlfriend and have resided together as a family for approximately five years. The defendant positively identified the victim as the person who committed the offense. I positively identified the defendant via her Florida driver's license.
