Narrative:

On 3/2/21 I responded to 3661 Quantum Blvd #208 in reference to a disturbance. Upon arrival, contact was made with W/F Lauren Andrade, who was sitting in her vehicle which was parked just below the apartment, approximately 75 feet away from the door. Andrade appeared upset and crying but declined to tell me why she was there. I next made contact with the caller, W/M Nicholas Wilder, who resides in the apartment and was inside the apartment at the time. Wilder stated that Andrade had been in her vehicle in the parking lot and knocked on his door attempting to make physical contact with him. He stated there was never any physical confrontation and he never allowed her in the apartment. He is aware that there is currently a no-contact order against her and she remained in the parking lot refusing to leave so he contacted the police.

After speaking with both parties a records check confirmed a current and active no-contact order for Andrade with Wilder listed as the victim. Once this was confirmed I instructed Wilder to exit the vehicle, however she refused and attempted to drive away. Andrade attempted to shift her vehicle into gear and I could hear the engine revving, luckily the vehicle was only shifted into neutral so the vehicle did not move. I immediately entered the vehicle with Andrade still in the drivers seat, and attempted to place the vehicle in park and was able to turn the ignition off to prevent the vehicle from leaving or striking an officer on scene. While I was in the vehicle, Andrade was able to move over the passenger seat, however Sgt. Munro was standing at the door. While Sgt Munro was attempting to remove her from the vehicle, she began aggressively kicking toward both Sgt Munro and myself. We were eventually able to remove her from the vehicle while she continued to actively resist, eventually placing her into handcuffs.

Based on the fact that Andrade was in clear violation of her no-contact order intentionally placing herself within 500 feet of Wilder, and the fact she actively resisted arrest by physically kicking toward officers while in her vehicle, probable cause exists for the arrest of Lauren Wilder for violation of no contact order as per FSS 921.244 and resisting arrest with violence as per FSS 843.01.

Andrade was eventually transported to BBPD where she was processed and later turned over to PBCJ. Additionally, while being placed under arrest, Andrade stated she wanted to kill herself. The proper area was noted on the rough arrest and PBSO staff was notified.



- NO direct or indirect contact by a third person on behalf of the Defendant. This does not prohibit an attorney for the Defendant, consistent with Rules regulating The Florida Bar from communicating with any person protected by the no contact order for lawful purposes.
- NO communication of any kind including telephone calls, messages on answering machines and voice or electronic; all written forms of communication, including letters of apology; or any other means of communication, including the delivery of gifts at any time, either at a residence, school, or workplace.
- The Defendant is prohibited from being within 500 feet of the victim's or other named person's residence, even if the Defendant and the victim or other named person share the residence.
- The Defendant is prohibited from being within 500 feet of the victim's or other named person's vehicle, place of employment, or a specified place frequented regularly by such person.
- The Defendant is prohibited from the following addresses (victim's home/job, if child involved school address/aftercare center/address for extracurricular activities):
