The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On 12/05/2019 at 2325 hours I responded to the Joy Food Store parking lot at 1907 Himes Av N after Tampa Police Officer Matthew Buck(71845) observed signs of impairment while interviewing the driver(defendant Putrow) in a single vehicle traffic crash where the defendant crashed her black 2017 Lexus SUV, FL Tag IRQJ52 into the ice machine outside of the store causing approximately \$4000.00 in damages. Suspecting that the defendant was impaired Officer Buck requested a DUI unit. Upon my arrival I made contact with the defendant who was still in the driver seat of her SUV and immediately observed that she had glassy eyes, appeared confused, and had a disheveled appearance. Then as I explained to her who I was and why I was there I detected a distinct odor of an alcoholic beverage. The defendant then invoked her Miranda rights and refused to perform the SFSEs. At which time I placed her under arrest for DUI based upon all of my observations made thus far in my investigation. The time of arrest was 2331hours. I then transported the defendant to the HCSO/CBT Facility where she refused to submit to a breath test. I identified the defendant with a valid FL DL. The listed witness positively identified the defendant as the driver of the vehicle that crashed into his ice machine.
