D.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

I responded to the intersection of Browning Drive and CoK Lane in West Palm Beach for a traffic stop that was conducted by D/S Norris #24996. Upon my arrival D/S Norris advised me of the following:

"On 04/17/2020 at approximately 2006hrs I was at the intersection of Kirk Rd and Gun Club Rd., West Palm Beach, FL 33406.

I was positioned south on Kirk Rd to head east. I observed a white Dodge facing north on Kirk Rd to head west, when the light turned green. The white Dodge proceeded west and turned into the path of a white Ford F150 that was heading south on Kirk Rd., which almost caused a collision.

I proceeded after the white Dodge as it proceeded north on E Browning Dr at a high rate of speed. As I caught up to the vehicle and initiated my red and blue lights for the traffic violation. The vehicle came to a stop at 76 E Browning Drive. I made contact with the driver and sole occupant later identified as W/F Laurie Rose 08/28/1970 at the drivers door. I had the smell of an unknown alcoholic beverage emitting from her person while she was stating "I just need to go home." I asked Rose for her driver license and registration and she was fumbling around in her wallet looking for her license. I asked if she knows what area she is in and she stated I just want to go home, I'm right here. I then asked if she had any alcohol today and she stated I just left Johnny Q's and had a couple drinks."

OBSERVATION OF DRIVER:

I made contact with the defendant wearing a gray long sleeve coat and blue jeans. The defendant was sitting in the driver seat and was the sole occupant. I immediately smelled the odor of an unknown alcoholic beverage coming from her breath that would intensify as she spoke. Her eyes were bloodshot and glassy and her gaze was distant and not focused. When I asked the defendant to walk to my vehicle she weaved and stumbled. I asked her to stop in front of my car and she walked past the front end of the vehicle along the driver side and had to be asked several times to return to the front of the vehicle to speak with me. Numerous times the defendant said that she was five houses away from being home. The defendant stated multiple times that she had to urinate. I informed her that there were no facilities around for me to allow her to use. I told her she could use a hedge line area if she chose to. She immediately went around the far side of a parked vehicle and used a grass area between the vehicle and a residential fence. She then returned to my location and I asked her how much alcohol she consumed. The defendant told me she consumed a "couple of drinks." I requested she perform roadside tasks. The defendant stated she was always told to refuse. I explained to the defendant if she refused to perform roadside tasks, I would be forced me to conclude my investigation and determine her impairment solely with the facts at hand and her refusal could be used against her in court. I asked if she understood and she asked again what would happen if she refuses. I explained once more and provided her with several opportunities to dispel my fears that she was unable to operate a motor vehicle safely. The defendant again refused and was placed into handcuffs which were checked for proper fit and double locked.

I just want to go home. I live 5 houses away. I had a couple drinks. I don't understand.
