The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The victim and defendant were engaged in a verbal altercation inside this location near the concierge desk because the defendant lost his house keys and was upset about it. It is noted the victim is a licensed Marksman Security Officer who was wearing an issued security uniform with insignias (License # D 3017193). The altercation then became physical when the defendant exited the office, removed his shirt then reentered and pushed the victim intentionally and against his will, causing the victim to fall to the ground. The victim sustained minor injuries to his face and complaint of hand pain. The defendant was very intoxicated and admitted to being in a physical altercation. Several citizens on scene described the defendant to be the aggressor, but they did not wish to be involved with this case. Video surveillance was recovered, which showed the defendant battering the victim and the altercation lasting approximately 2 minutes. The defendant was ID via his FL driver's license.
