The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was operating a red 2011 Jeep, 4 door, Florida tag GBWT04. The defendant stopped beyond a painted stop line at a red traffic light. The defendant drove in a manner in which the vehicle tires drifted onto and over painted lane markers, straddled painted lane markers, and she drove at speeds of 50-54 MPH in a properly posted 40 MPH speed limit (visually estimated and patrol car 5055 paced). The defendant made late decisions to make turns, turned left from a through lane rather than a designated left turn lane, and she stopped and reversed (the wrong way) on a one way roadway. A traffic stop was conducted to check on the driver's well fare in order to determine if she were sick, tired, or impaired. The defendant had a distinct odor of an alcoholic beverage on her breath. The defendant's eyes were bloodshot, glassy, and watery, and her face exhibited flushing. The defendant displayed cognitive issues as related to requested documents. The defendant stated she had consumed alcoholic beverages but claimed it was more than 5 hours prior to this interaction. The defendant was mildly unsteady exiting the vehicle, and she exhibited an upper body sway while standing. The defendant agreed to submit to Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and based on the totality of the circumstances she was arrested for DUI. The defendant provided breath samples of .133% BrAC and .137% BrAC. The defendant was positively identified by her Florida DL.
