The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 06/06/2021 at approximately 1534hrs, Affiant conducted a vessel stop on a 22' blue / white Nautic Star bearing FL6429SU / Hin #JNT32941G021 within 1 Seddon Channel Tampa, Hillsborough County, Florida 33605 for an idle speed violation (citation V374831). Upon stopping the vessel, affiant made contact with the operator/defendant, who was sitting at the helm with his hands on the steering wheel. During personal contact with the defendant, affiant observed him to have blood shot watery eyes and detected an odor of an alcoholic beverage coming from his breath. Based on this, affiant requested the defendant perform seated sobriety tasks to determine if he was operating a vessel while under the influence of an alcoholic beverage and/or controlled/illegal narcotic. The defendant agreed to the task. Based on observations of impairment, the affiant arrested the defendant for boating under the influence. The defendant was advised Florida Implied Consent (1553hrs) and agreed to a breath test. The defendant was transported to Central breath Test. After a 20 minute face to face observation period, the defendant provided breath samples of .031 / .030. Due to the defendants breath sample not being consistent with the performance of the SFSTs. Affiant requested a urine sample to determine the presence of control/illegal narcotics (1654 hrs). The defendant agreed, but after several attempts was not able to provide a urine sample. The defendant verbally identified himself and produced a Florida driver's license.
