

Kyotikki, Ofc. Alami and Sgt Brown who advised me that they made contact with W/F Leah Jones, who was sitting in the driver seat of a black Volkswagen FL tag# QQIU90. They advised that the vehicle engine was running and that the keys was inside of the vehicle (push start ignition), giving Jones full control of the vehicle. I made contact with Jones, who appeared intoxicated as I could smell a strong odor of alcohol emanating from her breath, and Jones had glossy eyes and slurred speech. As I was trying to talk to Jones, she was on her cellphone talking to someone else, not paying attention to my commands. I asked Jones multiple times to listen to my commands as I was trying to conduct a DUI investigation. Jones did not comply, and due to the facts mentioned above, Jones was placed under arrest with a refusal to conduct roadblocks. As I attempted to escort Jones out of her vehicle, I attempted to grab her left arm, and Jones began to pull away, tensing both of her arms. Once out of the vehicle, Jones began to act belligerent by yelling, pulling away, and tensing both of her legs and arms. After few moments of struggle, Officers were able to secure Jones by using handcuffs and a hobble. Jones was later placed on the back of the patrol vehicle, where she was transported to PBCJ BAT.</p> <p>Based on the above facts, Probable Cause exists to charge the defendant Leah Jones with one count of Resist/Obstruct Officer W/O Violence per F.S.S 843.02 and for DUI per F.S.S. 316.193(1)A.</p>

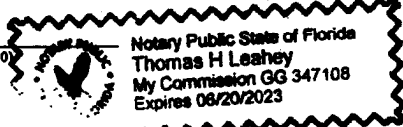

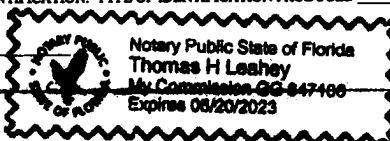

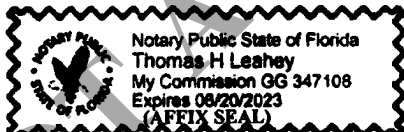
