The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was stopped after she appeared sleeping at intersection, drifting in lane, and appearing as though she was going to strike a patrol car with emergency lights activated, while driving a Acura SUV (IA Tag HCM686). During observations, the defendant displayed multiple clues of impairment to include, bloodshot/glassy eyes, slurred speech, unsteady on feet, and the distinct odor of alcohol emanating from his breath.

During SFSEs, the defendant displayed additional clues of impairment, and was arrested for DUI.

While at Central Breath Test, the defendant provided a breath sample, which yielded a BrAC result of .150/.163

The defendant was identified via his Iowa driver's license.
