 On 10/27/2021, at approximately 2212 hours, Deputy Swain (257388) responded to 6403 Jamesville Dr, in regards to a Traffic Crash with Injuries call for service involving a blue Honda Fit FL tag: (JWFA65). The defendant was operating the Honda when she attempted to pull into a parking space and struck the victim with the front of the Honda, causing the victim to have leg pain. The victim observed the defendant as the driver of the Honda and to be the sole occupant. The traffic crash was investigated by Deputy Swain under HCSO case #21-721924 (DHSMV #24627595). Upon contact with the defendant, she had bloodshot glassy eyes and the distinct odor of an alcoholic beverage emitted from her breath as she spoke. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which she agreed. During the exercises, the defendant showed signs of impairment and was placed under arrest for DUI. Implied consent (breath) was read and the defendant refused to provide two lawful samples of her breath. The defendant was positively identified via her FL DL.
