At this point, I energized my blue and red police lights in my unmarked PBSO vehicle in an attempt to initiate a traffic stop, which I announced on the radio. The vehicle continued to drive (at normal speed) refusing to stop. I continued to follow the vehicle as it swerved back and forth between lanes with my blue and red police lights energized, activating my police siren in an attempt to stop the vehicle. The vehicle then made a right turn on to Lilac Place, where it came to a stop on the right shoulder. Given the drivers hesitancy to stop, for my safety, I ordered him to turn the vehicle off and exit, which he did. Upon exiting, the driver, Lee Hughes, appeared to stagger out of the car. Upon getting closer to him, I detected a strong odor of alcohol emanating from his breath at which point I asked if he had anything to drink and he responded he had just left his friends house and had "two drinks". Additionally, his eyes appeared to be very glossy and he was unable to maintain a coherent conversation during my interaction with him. ## PERSONAL CONTACT

DRIVING PATTERN: Actual physical control (physical evidence or statements putting def. behind wheel of vehicle)

While traveling westbound on South Shore Blvd from Forest Hill Blvd I noticed a gray GMC pickup truck (Tag#IQ00AN) traveling the same direction in the #1 (left) lane. The vehicle caught my attention as it was unable to maintain its lane, traveling into the middle of the roadway into my lane (right, #2) of travel. As the vehicle maintained its travel into the middle of the roadway, it violently "jerked" back left into the #1 lane. This continued in excess of 5 times as we continued westbound to the intersection of South Shore Blvd and Greenview Shores Blvd. The vehicle then made a right hand turn, at which point it accelerated during the apex of the turn at such a high speed that the rear tires spun. The vehicle then traveled north on Greenview Shores in the #2 lane, once again swerving into the middle of the roadway and then into the bike lane, almost striking the cement curb on the right shoulder near a sidewalk. At this point, I energized my blue and red police lights in my unmarked PISO vehicle in an attempt to initiate a traffic stop, which I announced on the radio. The vehicle continued to drive (at normal speed) refusing to stop. I continued to follow the vehicle as it swerved back and forth between lanes with my blue and red police lights energized, activating my police siren in an attempt to stop the vehicle. The vehicle then made a right turn on to Lilac Place, where it came to a stop on the right shoulder. Given the drivers hesitancy to stop, for my safety, I ordered him to turn the vehicle off and exit, which he did. Upon exiting, the driver, Lee Hughes, appeared to stagger out of the car. Upon getting closer to him, I detected a strong odor of alcohol emanating from his breath at which point I asked if he had anything to drink and he responded he had just left his friends house and had "two drinks". Additionally, his eyes appeared to be very glossy and he was unable to maintain a coherent conversation during my interaction with him.

## OBSERVATION OF DRIVER:

Upon making contact with the defendant, I observed him to have a slow and slurred speech. He also had glassy, red, and bloodshot eyes. He was asked to walk to the front of my vehicle to speak with me, he swayed from side to side and was unable to keep his balance without using his arms. He staggered while walking. He was very talkative.

## DRIVER'S STATEMENTS:

The defendant stated he was on his way home from his friend's house. He stated he had 2 drinks of vodka and soda. He stated he may have had too much to drink. He stated he was unable to do the walk and turn even if he was sober.

## ODORS:

He had an obvious odor of an unknown alcoholic beverage coming from his breath which intensified as he spoke to me.

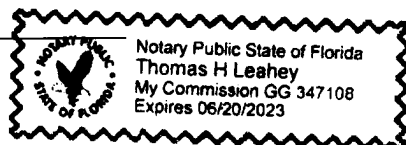

#### Other Observations:

The defendant was placed into the instructional stance for the horizontal gaze nystagmus. He identified the blue stimulus. He failed to maintain the instructional stance by stepping off to his side and using his arms for balance. He did not follow the stimulus as instructed. He turned his head several times and was told to keep his head straight.

#### WALK & TURN:

I explained and demonstrated the instructions for the Walk & Turn to him. He stated he understood and had no questions for me. He failed to maintain the instructional stance. He used his arms to balance himself. He stated he needed to urinate to help him complete the task. Prior to and after urinating he was explained the task numerous times. He began to walk down the line on his own. He stated that he could not do the task even if he was sober because it was impossible. He was unable to complete the task.

#### ONE LEG STAND:

I explained and demonstrated the instructions for the One Leg Stand to him. He stated he understood and had no questions for me. He failed to maintain the instructional stance. He used his arms for balance. He put his foot down and hopped several times prior to 30 seconds elapsing. After putting his foot down he began counting from 1 again. He was not looking at his elevated foot. He improperly counted as instructed by counting, 1 to 4 and putting his foot down.

#### FINGER TO NOSE:

I explained and demonstrated the instructions for the Finger to Nose task to him. He stated he understood and had no questions for me. He did not touch finger to nose and kept his hands to his side. On each attempt he only turned his face to the side. He did not keep his eyes closed as instructed. He did not keep his head tilted as instructed and was reminded.

#### RHOMBERG ALPHABET:

I explained and demonstrated the instructions for the Rhomberg Alphabet task to him. He stated he understood and had no questions for me. He stated he knew the English alphabet. He improperly recited the alphabet going from the letter A to W, X, I, and Z then W, X, Y, and Z.

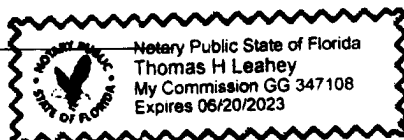

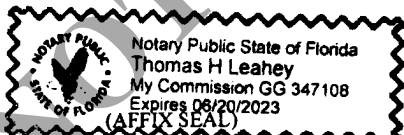
