females and one male. I continued to watch the motorcycles as they weaved in and out of traffic, traveled in between other vehicles, all while they continued to travel at a high rate of speed as they continued to travel south. In my opinion I believe their operation of the motorcycles were reckless.

I contacted dispatch (LWRCC) via radio and had them BOLO out the motorcycles to all the units south of my location. As I was approaching the Lake Worth Service Plaza located on the Florida Turnpike I was notified by Trooper Jeffries that the motorcycles were sitting stationary at gas pump 8 at the Shell Gas Station.

Upon entering the service plaza I proceeded to pump 8 and as I was pulling up I activated my emergency equipment. Upon coming to a stop I exited my vehicle and approached the three individuals to conduct a stop for the reckless driving. As I was approaching them in my division issued uniform, I told all three individuals to turn off their motorcycles. As this was occurring the male and one of the female fled the scene on their motorcycles. One went north and one went south. The other female stayed on scene.

I then obtained the driver's license for the female that remained on scene and copied down the tag, which at this point was folded in half and located in a manor that was not stock to the motorcycle. After running the tag and driver's license of the driver, the driver came back with just a Class E license and no motorcycle endorsement and the motorcycle came back stolen.

After LWRCC confirmed it was stolen the driver was placed under arrest for the Reckless Driving, Operating a Motorcycle without a Motorcycle Endorsement, and in Possession of a Stolen Vehicle. The driver was turned over to Trooper Wallace and Trooper Rodriguez for booking due to Trooper Rodriguez being in his FTO process.

Additionally, other units were able to locate the motorcycle (tag 725 that was being operated by the male in the Target parking lot located off of Boynton Beach Blvd which is just east of the Florida Turnpike. It should be noted that the motorcycle appears to be stolen due to the wires leading to the ignition being tampered with.

Probable Cause

On May 1, 2020 Trooper Rodriguez (ID#1812) and myself were on a traffic stop southbound SR 91 (FL Turnpike) at the 118 mile marker. We observed 3 motorcycle heading southbound at a high rate of speed as they pass us one or more of the motorcycles revved their engine. Moments later SGT Cichoski (ID #251) at the 104 mile marker he BOLO'ed the same three motorcycles and moments after that he came in contact with one of the drivers. (Attached Narrative SGT H.J. Cichoski)

Tpr Rodriguez and I then drove to the Lake Worth Plaza to meet with Sgt Cichoski and the suspect. As we headed south it became known that the vehicle Sgt Cichoski came contact with was stolen, the driver did not have a motorcycle endorsement and the vehicle tag was bent up and not visible.

We then took the suspect identified with Florida Driver license as Leidysneri Camacho Borroto DOB 12/23/2001 FL DL# C521 520 01 963 0.

We called for a female Trooper to do a search TPR B. Derissier arrived and search the female suspect. Tpr Rodriguez and I then transport Camacho to the Palm Beach county jail and charged her with the:
