On 5/1/2022 at approximately 1830hrs, I was conducting vehicle patrol in the area of S Alt A1A and 3 Palms Plaza, Jupiter, Palm Beach County, Florida. I was operating an unmarked Jupiter Police vehicle with lights and sirens equipped and I was in full Jupiter Police uniform with my department issued Axon BWC activated. While traveling southbound on S Alt A1A, I observed a black Land Rover bearing FL Tag 38AGTQ go from the right lane to the middle lane and accelerate quickly around other vehicles. I visually estimated the vehicle to be traveling in excess of 65mph in a posted 50mph zone. I activated my vehicle mounted Stalker Radar which provided a true speed of 67mph in a posted 50mph zone. Based upon the aforementioned traffic violation, I conducted a traffic stop by activating my red and blue emergency lights and sirens to signal the vehicle to pull over. The vehicle slowed down in the left lane to approximately 7mph in a posted 50mph zone and continued southbound. After traveling southbound for a substantial period below 10mph the vehicle eventually merged to the right side of the roadway and came to a complete stop on the right shoulder. I made contact with the driver and sole occupant of the vehicle who was later positively identified by his FL Driver License to be WM Leonard A. Kosar (3/10/1962). Upon making contact with Kosar I immediately noticed the strong odor of an unknown alcoholic beverage coming from Kosar. I also noticed that he had red bloodshot glassy eyes. Kosar explained he was coming from a friends house and had 3-4 beers tonight. Kosar explained that they were standard beer bottles. Kosar was asked on a scale of 1-10 with 1 being completely sober and 10 being the most drunk he has ever been in his life where he thought he was at. Kosar stated about a 4. Kosar also stated he thought he was ok to be driving. Kosar explained he did have back issues that were diagnosed a few months ago but the only thing he was doing to treat it was "inversion therapy." Kosar denied having any other medical issues. Kosar was asked to step out of his vehicle and he complied with the request. Kosar was

unsteady on his feet and swayed slightly while standing still. Based upon all of my observations of Kosar and the totality of circumstances, I asked him to perform Standardized Field Sobriety Tasks (SFSTs). Kosar agreed to perform the tasks. See DUI PC for further. Kosar performed poorly on SFSTs and I developed probable cause to arrest and charge Kosar with DUI pursuant to Florida State Statutes. Kosar was secured in handcuffs which were double locked and checked for spacing. While searching Kosar I observed two "gum drop" type gummies in Kosar's right pocket and I asked Kosar what they were. Kosar explained they were "gummies" I asked Kosar if they were THC gummies and he stated yes. The gummies were later submitted into Jupiter Police Evidence to be tested and charges are pending the results of the lab tests. Kosar was later requested to provide a sample of his breath on the roadside and he agreed to take a breath test. Kosar was later transported to the Palm Beach County Jail BAT Facility. After a 20 minute observation period, Kosar was again asked to provide a sample of his breath and he agreed. While waiting for the instrument, Kosar questioned the test and was read implied consent from a preprinted card and again agreed to take the test. Kosar provided two breath samples of .115 and .115. Kosar was secured in a holding cell while the appropriate booking paperwork was completed. Kosar was later turned over to the Palm Beach County Jail booking staff without incident.
