Kraus (ABN:254717) on a traffic stop. Dep. Kraus observed a red 2019 Mercedes Benz bearing FL tag #NLNA25 (Vin:WDDWJ8DB3KF782091) traveling westbound on I-4. This vehicle failed to maintain a single lane. Dep. Kraus had to apply his brakes to avoid this vehicle from entering his lane. Dep. Kraus observe this vehicle accelerate rapidly at a high rate of speed. Dep. Kraus conducted a traffic stop on this vehicle at the above listed location. Dep. Kraus observed signs of impairment to include bloodshot watery eyes, slurred speech, and the odor of an alcoholic beverage emitting from his breath. Upon making contact with the defendant I observed signs of impairment to include bloodshot watery eyes, slurred speech, and the odor of an alcoholic beverage emitting from his breath. Post Miranda, the defendant invoked his right. Standardized Field Sobriety Exercises were conducted and impairment was observed. The defendant was arrested for DUI and provided two lawful breath samples after a 20 minute observation period (BAC .231 /.221). The defendant was identified by his Florida driver's license.
