The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 02/16/2020 at 0037 hours I responded to 15th St N just north of Palm Av E after Tampa Police Officers N.Hardesty(70806) and A.Harrison(71308) found the listed defendant passed out in the driver seat of her still running 2004 blue Lincoln sedan FI tag LYHJ64 that was stopped on 15th St N blocking northbound traffic. Upon contact with the defendant the officers observed signs of impairment. Suspecting that the defendant was impaired the officers requested a DUI unit. Upon my arrival I made contact with the defendant and immediately observed that she had extremely bloodshot glassy eyes and appeared very lethargic. Her movements were very slow and she mumbled with slurred speech as she attempted to answer my questions. As I explained to her who I was and why I was there I detected a very strong and distinct odor of an alcoholic beverage. The defendant then refused to get out of her vehicle. After repeatedly asking her to get out of her vehicle and her refusal to cooperate I placed her under arrest for DUI based upon all of my observations made thus far in my investigation. The time of arrest was 0045 hours. I then transported the defendant to the HCSO/CBT Facility where she refused to submit to a breath test. Implied Consent was read at 0113 hours. I identified the defendant with a valid FL DL. Post Miranda the defendant invoked her rights.
