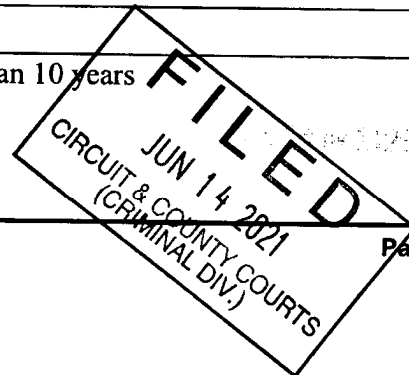

VI. DETAILS OF DUI

A. Phase 1 - Initial Observation of vehicle in operation

At approximately 9:38PM, on 13 June 2021, I, Officer Dillan Hudson, of the Florida Fish and Wildlife Conservation Commission (FWC), along with Officer Stoker also of FWC were conducting surveillance for night hunters along 710 right by Corbett North Check, in Palm Beach County.

I observed a vehicle bearing Florida registration number HNZT18, that was being operated by a subject who was identified by valid Florida Driver license number, F420-534-87-444-0, as Levi Orion Fulk, stop in the middle of the road behind me in Corbett.

I observed three small children in the back of the truck with a lady. None of the children were in a seat belt. Fulk exited the vehicle from the driver's seat, bracing himself and Officer Stoker and I walked over to the vehicle to see why they stopped in the middle of the road.

B. Phase 2 - Personal Contact with Operator of Vehicle

I asked Fulk for his day use pass, which Fulk is required to possess inside of Corbett, to which he did not have.

I observed Fulk's eyes to be blood shot and glassy. Fulk's speech was slurred and mumbled. I smelled a strong odor of an unknown alcoholic beverage emitting from Fulk's breath at a conversational distance while outside.

I asked Fulk how much he had to drink today, to which he stated that he had 2 beers. I asked Fulk if he littered the alcohol, to which he stated that he kept the empties. I asked Fulk where his empties were, to which he stated that they were inside the vehicle. I asked Fulk to produce the empties, to which he opened the door a crack and pulled two empty beer cans out. I could hear more empty beer cans in the vehicle as well.

Fulk had a total of 6 empty beer cans and 1 empty tall boy inside the vehicle.

I asked Fulk if it was okay if I made sure he was okay to drive, to which he agreed.

C. Phase 3- Pre-arrest screening and Observations of Operator

**Pre task Questions:**

Subject stated he had no physical defects or disabilities.

Subject stated he had no defects with his eyes.

Subject stated he was not sick or injured.

Subject stated he was not under the care of a doctor or dentist.

Subject stated he was taking anti-depressants and anti-anxiety drugs.

Subject stated he was taking Prozac and another medication. He stated he took them this morning.

Fulk asked if this was a DUI investigation, to which I told him that it was. Fulk stated that he didn't know how his medications reacted with alcohol. Fulk stated that he didn't want to lose his family and that if he had to, he could uber home. Fulk asked us that if we decided that he was not sober, to let him get a uber home. Fulk stated that he has two prior DUI's from when he was younger.

**Horizontal Gaze Nystagmus:**

Subject stated he was not wearing contacts.

Subject stated he understood the instructions.

Subject showed Lack of Smooth Pursuit in left and right eye.

Subject showed Distinct and Sustained Nystagmus at Maximum Deviation in left and right eye.

While checking for distinct and sustained Nystagmus at maximum deviation, Fulk stated "I can feel that". I asked what he could feel, to which he stated "nystagmus", I asked if he could feel it, to which he stated "Yeah". Fulk then stated, "I figure I've been drinking and it's too much I'm not good to drive." and stopped looking at the stimulus. I tried to continue the task, to which Fulk stated, "there it is, I don't like it, why do we have to continue?" HGN task was stopped because he was not looking at stimulus.

I asked Fulk if he wanted to continue Standardized Field sobriety tasks, to which he continued to ask about his family and plead for us to not to arrest him. Fulk began to become emotionally unstable and had a major mood swing. I asked Fulk if he would do Standardized Field sobriety tasks, to which he stated that he would not.

**D. Arrest of Operator**

Based on the vehicle in motion, personal contact with the operator, Standardized Field Sobriety Tasks, admission from the operator that he was "not good to drive", and the totality of circumstances, I placed Fulk under arrest for Driving Under the Influence. I double locked the handcuffs and checked for tightness.

Fulk had three children under 18, and his pregnant wife in his vehicle at the time he was Driving under the influence. Matias Bernal Suarez 10/7/15, Emily Bernal Suarez 12/27/16, Penelope Fulk Suarez 11/15/19, and Natalia Suarez Galindo 11/28/1987.

I transported Fulk to the Palm Beach County Jail.

I read Fulk implied consent. Fulk refused to provide a breath sample. I read Fulk his miranda rights, to which he stated that he understood them. Fulk stated that he was driving at the time of the stop inside of Corbett. When Fulk



**B. Phase 2 - Personal Contact with Operator of Vehicle**

I asked Fulk for his day use pass, which Fulk is required to possess inside of Corbett, to which he did not have.

I observed Fulk's eyes to be blood shot and glassy. Fulk's speech was slurred and mumbled. I smelled a strong odor of an unknown alcoholic beverage emitting from Fulk's breath at a conversational distance while outside.

I asked Fulk how much he had to drink today, to which he stated that he had 2 beers. I asked Fulk if he littered the alcohol, to which he stated that he kept the empties. I asked Fulk where his empties were, to which he stated that they were inside the vehicle. I asked Fulk to produce the empties, to which he opened the door a crack and pulled two empty beer cans out. I could hear more empty beer cans in the vehicle as well.

Fulk had a total of 6 empty beer cans and 1 empty tall boy inside the vehicle.

I asked Fulk if it was okay if I made sure he was okay to drive, to which he agreed.

**C. Phase 3- Pre-arrest screening and Observations of Operator**

**Standardized Field Sobriety Tasks**

**Pre task Questions:**

Subject stated he had no physical defects or disabilities.

Subject stated he had no defects with his eyes.

Subject stated he was not sick or injured.

Subject stated he was not under the care of a doctor or dentist.

Subject stated he was taking anti-depressants and anti-anxiety drugs.

Subject stated he was taking Prozac and another medication. He stated he took them this morning.

Fulk asked if this was a DUI investigation, to which I told him that it was. Fulk stated that he didn't know how his medications reacted with alcohol. Fulk stated that he didn't want to lose his family and that if he had to, he could uber home. Fulk asked us that if we decided that he was not sober, to let him get a uber home. Fulk stated that he has two prior DUI's from when he was younger.

**Horizontal Gaze Nystagmus:**

Subject stated he was not wearing contacts.

Subject stated he understood the instructions.

Subject showed Lack of Smooth Pursuit in left and right eye.

Subject showed Distinct and Sustained Nystagmus at Maximum Deviation in left and right eye.

While checking for distinct and sustained Nystagmus at maximum deviation, Fulk stated "I can feel that". I asked

what he could feel, to which he stated "nystagmus", I asked if he could feel it, to which he stated "Yeah". Fulk then stated, "I figure I've been drinking and it's too much I'm not good to drive." and stopped looking at the stimulus. I tried to continue the task, to which Fulk stated, "there it is, I don't like it, why do we have to continue?" HGN task was stopped because he was not looking at stimulus.

I asked Fulk if he wanted to continue Standardized Field sobriety tasks, to which he continued to ask about his family and plead for us to not to arrest him. Fulk began to become emotionally unstable and had a major mood swing. I asked Fulk if he would do Standardized Field sobriety tasks, to which he stated that he would not.

**D. Arrest of Operator**

Based on the vehicle in motion, personal contact with the operator, Standardized Field Sobriety Tasks, admission from the operator that he was "not good to drive", and the totality of circumstances, I placed Fulk under arrest for Driving Under the Influence. I double locked the handcuffs and checked for tightness.

Fulk had three children under 18, and his pregnant wife in his vehicle at the time he was Driving under the influence. Matias Bernal Suarez 10/7/15, Emily Bernal Suarez 12/27/16, Penelope Fulk Suarez 11/15/19, and Natalia Suarez Galindo 11/28/1987.

I transported Fulk to the Palm Beach County Jail.

I read Fulk implied consent. Fulk refused to provide a breath sample. I read Fulk his miranda rights, to which he stated that he understood them. Fulk stated that he was driving at the time of the stop inside of Corbett. When Fulk was asked what time he thought it was, he stated that he did not want to answer any questions at that time, to which questioning was stopped.

**E. Disposition of operator and Vehicle**

Fulk's vehicle and family was turned over to a friend on scene.

Fulk was booked into the Palm Beach County Jail under the following charges:

F.S. 316.193(2)(b)(2)-DUI 3RD OFFENSE MORE THAN 10 YEARS

F.S. 316.1939(1)(a)- REFUSAL TO SUBMIT TO BREATH TEST

I issued Fulk a citation for consumption of alcohol inside of Corbett, for not having the minors in child restraints, and a warning for not having the day use pass to access Corbett.

My agency issued body camera was on and recording. Body camera video of the interaction was saved according to agency policy.

On June 13, 2021, I Officer Ronald Stoker and Officer Dillan Hudson of the Florida Fish and Wildlife Conservation Commission (FWC) were on marked road patrol conducting surveillance for potential night hunting at the J.W. Corbett W.M.A. North check.

I asked if everything was okay, and the male operator said they were on a haybale ride. There were no haybales present in the bed of the truck.

I got closer to the operator of the vehicle, later identified by his (FLDL 42053487440) as Mr. Levi Fulk, I detected a strong odor of an unknown alcoholic beverage emitting from his breath, his eyes were blood shot and glassy, and he displayed a slurred speech while conversing with myself.

Officer Hudson asked Mr. Fulk how much he had to drink today, and he said two beers. He pulled the two empty beer cans out from a plastic bag behind the driver's side door. I could see more empty beer cans in plain view inside the bag.

Officer Hudson and I walked Mr. Fulk over to our patrol vehicles away from the children to further the DUI investigation. After Officer Hudson checked Mr. Fulk's eyes for HGN, he refused to complete the rest of the Field Sobriety Exercises. At 2151 hours Officer Hudson placed Mr. Fulk under arrest for the suspicion of driving under the influence.

I photographed six empty Terrapin beer cans as well as one empty tall boy Twisted Tea with my agency issued camera.

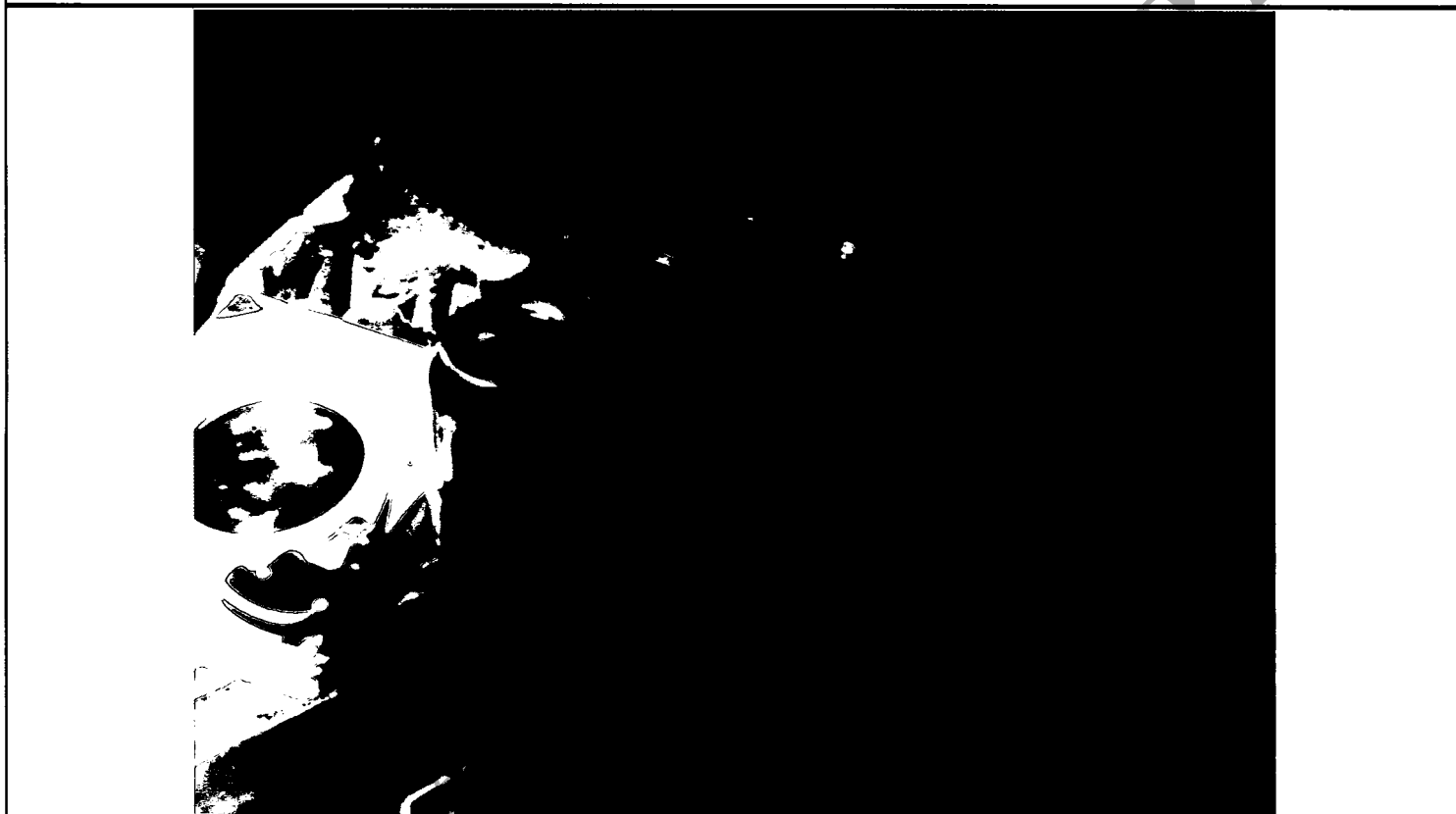
