The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was stopped after she was driving the wrong way I275 N (south in the northbound lanes) then drove her vehicle off the roadway and through the grassy area between the interstate and the chain-link fence at the street level. The defendant was driving her 2002 Infiniti SUV, bearing FL tag #LXHS34. Upon making contact with the defendant, she displayed several indicators of impairment, including: slurred speech, a strong odor of an alcoholic beverage on her breath, bloodshot/glassy eyes, swaying, unsteady on her feet, stumbling and staggering as she walked, and fumbling and uncoordinated movements. The defendant performed poorly on the SFSEs and extreme difficulty following simple instructions. The defendant was arrested for DUI and later submitted to the breath test, which had a BrAC of .183/.186. The defendant identified herself via her FL driver's license.
