	<p>Upon my arrival, I met with the reporting party, Daniel J. Moore (W/M, DOB 06/06/1958), outside and in front of his residence. Moore stated he has been married 33 years and has 3 children in common.</p> <p>Moore further stated him and his wife, Linda J. Moore (W/F, DOB 10/11/1955), had been drinking when she requested to search his phone. D. Moore stated he was gambling on his phone and did not want his wife to see it. D. Moore then stated he tried to put his phone away and that L. Moore tried to prevent him by trying to grab the phone from his hand. D. Moore said he used his left arm to block her from grabbing his phone. He then stated they wrestled, rolled around in the bed, and that she scratched his forearm. D. Moore had visible scratch marks on his left forearm. D. Moore stated when he was able to get away from L. Moore he called for police services.</p> <p>I then met with L. Moore within the residence. As I entered the door, L. Moore spontaneously stated "why did he call the Police." L. Moore advised she and J. Moore have been drinking earlier in the evening. She stated she saw J. Moore on his cell phone and confronted him about it. She thought he was talking to another woman and said he had a history of cheating on her. L. Moore then stated she tried to obtain the phone to see if J. Moore had been speaking with another woman. She further stated that she tried to reach for his phone and was unable to take it due to his size and strength. L. Moore said she tried to grab the phone again, at which point they began to wrestle over it on the bed. L. Moore then stated D. Moore grabbed her neck and choked her (no marks of choking were observed). I observed small dark red patches on her left forearm, with the uppermost one open and lightly bleeding. I asked L. Moore how she had received the marks to which she stated she didn't know and that she takes blood thinners. The marks appeared to be old/preexisting.</p> <p>Based on my investigation, I believe probable cause exists to charge Linda Moore with domestic battery pursuant F.S.S 784.03(1) (a) (1).</p> <p>No further information, end of report.</p>
