The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On the above listed date and time, at the above listed location, Deputy Mullen #228775, arrived at the above listed location and observed a white Mazda 3 bearing Florida tag: Y59DMA crashed into a red Dodge Ram bearing Florida tag: NVW287. Upon making contact with the driver/defendant, She observed signs of impairment. Deputy Rivers #220676, arrived to conduct the crash investigation (HCSO 20-716306; DHSMV #89440527). Deputy Rivers advised me the damage was approximately \$3000 dollars. I responded to the scene, detected signs of impairment. I requested the defendant perform Standard Field Sobriety Exercises (SFSEs,) which the defendant agreed to perform. Due to the defendant's level of intoxication, the defendant was unable to perform the exercises. The defendant then was subsequently arrested for DUI. After a proper 20 minute observation period was conducted, the defendant provided two lawful samples of her breath which resulted in a BrAC of .375/.391. The defendant was identified via her Florida Driver's License.
