The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant and victim were ex-girlfriend/ex-boyfriend from over 11yrs ago. The victim was sitting at the far side of the bar at the listed location when the defendant walked in. The defendant walked up to the victim, called him a piece of shit, and punched the victim in the nose. As the victim stood up to get away from the defendant, the defendant picked up a glass beer bottle and threw it at the victim's head. The victim ducked as the glass bottle flew over the top of the victim's head, just missing him. The victim was punched and assaulted against his will and without his permission. The defendant was very intoxicated when LEO's made contact with her and became very aggressive towards all parties on scene. The defendant was so intoxicated she could not understand simple instruction's given by LEO's on scene. There were no signs of injury to the victim but he showed a bloody napkin which he used to wipe blood from his nose. All medical attention was refused on scene. Criminal History was ran on the defendant which returned with negative results for prior battery convictions.
