The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was observed to be driving a white 2019 Toyota Camry (FL Tag #LMIR76) northbound on Howard Av N, very aggressively. She was purposefully weaving back and forth in her lane, following 3 feet behind the vehicle in front of her, passing the vehicle on the right and cutting it off, then sped to 57 mph in a posted 40 mph zone. During the traffic stop for the infractions and suspicious driving patterns, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, avoided eye contact, had slurred speech, confusion with her paperwork, admitted to drinking "2 drinks and a shot" prior to driving, and emitted a distinct odor of an alcoholic beverage from her breath. She was arrested for DUI following a poor performance on SFSEs, and was transported to booking. While at CBT, the defendant willingly provided 2 valid breath samples, measuring .143/.137 BrAC.
