(Specifically include facts constituting cause for arrest.)</p> <p>On 6/25/2021 at approximately 1647 hours I was contacted by Detective Vander-Laan who informed me that Victoria Canarelli reported to her that she was receiving possibly harassing or threatening text messages from a person and the substance of those threats were potentially related to the Homicide incident that took place on 6/22/2021 which was documented under PBSO case number 21-078608.</p> <p>I contacted V. Canarelli on the phone and was informed that she was staying at her brother's residence located at 16795 131st Way North, Jupiter Farms, FL, 33478 in unincorporated Palm Beach County. V. Canarelli advised that the suspect was a person by the name of Lindsey Reggio, a person whom she has known for several years. After completing a preliminary background investigation on Reggio I arrived at V. Canarelli's brother's residence at approximately 1854 hours. I met with V. Canarelli and asked her to explain to me what happened.</p> <p>On 6/22/2021 at approximately 2014 hours a shooting occurred which resulted in the death of V. Canarelli's fiancé, James Burger. As a results of that investigation, V. Canarelli's cell phone was seized temporarily for investigative purposes. V. Canarelli's cell phone was returned a few days later. Upon returned, V. Canarelli discovered a text message on her Facebook messenger from a person with the Facebook name "Stefano Sensi". The message was received on Tuesday, June 22nd 2021 at approximately 2205 hours and the substance of that message was as follows.</p> <p>"Bitch you better hope you fucking go down and rot and hell with your fucking lousy lousy fucked up husband. This is Lindsey and I swear to fucking God if I ever ever cross your fucking path again you are fucking done bitch you fucking hear me. You are so fucked up you have now ruined so many fucking lives with your fucking psychotic bullshit and now you're fucking senseless goddamn ways I swear to you on my life you are done" That statement was contained in one Facebook message.</p> <p>Underneath was another text message which stated the following. "Fucking psycho u are a terrible terrible person I hope karma gets you 7 ways from fucking Sunday bitch nasty bitch". A screen shot of this text message was properly sealed by me and submitted into the PBSO District 3 evidence locker.</p> <p>When asked, V. Canarelli advised that "Lindsey" in the message was most likely Lindsey Reggio, who is the girlfriend of Stefano Sensi-Davenport. The Facebook message was sent from Davenports Facebook account. On the screen shot of the Facebook message a photo is depicted at the top of the message. The photo contains two persons, a male wearing a black baseball cap and white shirt and a female with red hair wearing a black shirt. When asked, V. Canarelli identified these people as Lindsey Reggio and Stefano Sensi-Davenport. When asked how she knew who these people, she advised she has been friend with them for years and until recently had both these persons as friend on her Facebook page.</p>

<p>V. Canarelli provided me with a sworn witness statement. The following is a brief synopsis of V. Canarelli's statement, not to be taken a verbatim account. For full details the reader can refer to the audio statement submitted into evidence. V. Canarelli advised that when her cell phone was returned to her from the original investigation she noticed a Facebook message that she received from the Facebook name "Stefano Seni". The substance of that message, mentioned in the beginning of this report read ""Bitch you better hope you fucking go down and rot and hell with your fucking lousy lousy fucked up husband. This is Lindsey and I swear to fucking God if I ever ever cross your fucking path again you are fucking done bitch you fucking hear me. You are so fucked up you have now ruined so many fucking lives with your fucking psychotic bullshit and now you're fucking senseless goddamn ways I swear to you on my life you are done. Fucking psycho u are a terrible terrible person I hope karma gets you 7 ways from fucking Sunday bitch nasty bitch".</p> <p>V. Canarelli explained the friendship dynamic which exists between Lindsey Reggio and her boyfriend Stefano Sensi-Davenport. V. Canarelli reported that Reggio and Davenport were friends with Lisa Berger and James "Cole" Berger. Cole Berger is V. Canarelli finance who was shot and killed on 6/22/2021. When James Berger and Lisa Berger stopped seeing each other, he began dating and eventually got engaged to V. Canarelli. V. Canarelli advised that when she started seeing J. Berger she stopped talking with Reggio, Davenport and L. Berger. V. Canarelli claimed that Reggio and Davenport "took L. Berger's side". When asked what she was thinking when she received this message V. Canarelli advised she thought they were going to kill her. Reggio advised that Reggio knows where she is staying and has a code to the gate because she had been to this residence before. She is in fear that Reggio may act on her threats.</p> <p>Based on this investigation I determined that Lindsey Reggio violated Florida State Statue 836.10(1) – Written threats to kill, do bodily harm or injury.</p> <p>V. Canarelli provided me with Reggio's cell phone number however she did not answer. I conducted a computer check and learned that Reggio's most recent address was reported as 12354 153rd Court North, Jupiter, FL, 33478 in unincorporated Palm Beach County. At approximately 1942 hours I responded to the address listed in DAVID. There were no vehicles in the driveway and no one answered the door.</p> <p>I am requesting a warrant be issued for the arrest of Lindsey Reggio for violation of FSS 836.10(1) - Written or transcribed threats to do bodily harm.</p> <p>The list victim invoked Marsy law protecting her identity.</p>
